## REGISTRATION AND SUPERVISION

## MINIMUM INVESTMENT AMOUNT

The minimum investment for each investor resident in Norway (each a **Norwegian Investor**) shall be Norwegian Kroner 5,000,000 (or its foreign currency equivalent) except in respect of the following Classes of shares of the Sub Funds for which the minimum investment shall be the amount stated in the relevant Supplement:

The Directors or their delegate have the discretion to reduce the minimum investment as stated in the relevant Supplement for each Class of shares, provided that the reduced minimum investment requirement will not be below Norwegian Kroner 5,000,000 for any Norwegian Investors.
