# What is this product?

Type:

This is a UCITS Fund.

### Term:

Open Ended Fund.

## Objectives:

The Fund's primary objective is to grow the amount invested over the long term through investment in Equities and Debt Securities of issuers around the world. This may include securities of issuers in developing countries (which may constitute more than 20% of NAV). Investments in Russian securities are limited to 10% of NAV.

The Fund seeks to achieve its objective primarily through investing in Equities, typically comprising around 90% of NAV. The Fund may also invest in Debt Securities, typically not more than 10% of NAV. The amount of Debt Securities may be increased when market circumstances dictate.

The Investment Manager seeks to identify investments that will produce growth. Investment decisions are based on global economic developments, outlooks for securities markets, interest rates and inflation, supply and

The Fund is actively managed and is not constrained by any benchmark. However, the Fund uses the MSCI ACWI Net Total Return USD Index in the Fund's marketing materials to compare performance.

## Intended retail investor:

This Fund is intended for investors seeking capital growth over a long-term horizon who are prepared to accept a medium level of volatility from time to time.

We have classified this Fund as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact the value of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

#### Costs over time
