## How did the Fund perform for the past six months and what affected its performance?

The Fund's Class A shares outperformed the ICE BofA 1-10 Year U.S. Municipal Securities Index (the "Index") during the 6-month period ended March 31, 2025.

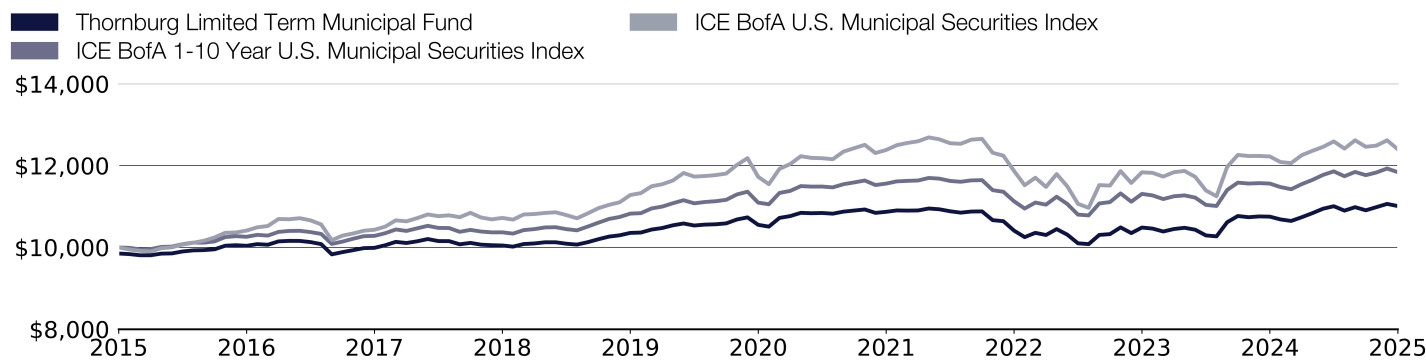
While underlying municipal credit remained strong, increased uncertainty around federal policy and higher market volatility acted as significant headwinds to Fund performance. Municipal market yields diverged as the Federal Reserve shifted policy during the period, which led to short-term yields experiencing modest declines while long-term yields notably increased.

While the divergence in yields was beneficial given the shorter duration bias of the portfolio, it also led to a negative impact from the Fund's yield curve positioning, which was the largest detractor from performance relative to the Index during the period.

## How did the Fund perform over the past 10 years?

The line graph below reflects a hypothetical \$10,000 investment and assumes the deduction of the maximum sales charge associated with that investment. The returns shown in the line graph and table assume the reinvestment of dividends and capital gains, but do not reflect the deduction of taxes that a shareholder would pay on distributions or the redemption of Fund shares. 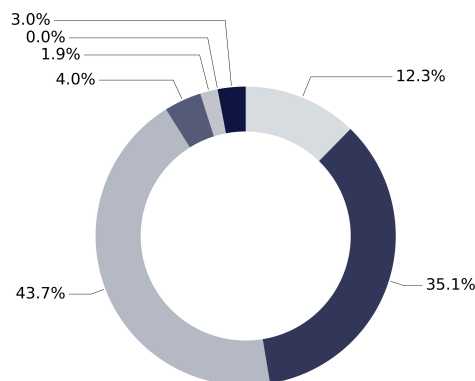
