## How did the Fund perform for the past six months and what affected its performance?

The Fund's Class A shares outperformed the ICE BofA U.S. Treasury Bill Index (the "Index") during the 6-month period ended March 31, 2025.


Long-term Treasury yields rose through the period as inflationary concerns resurfaced after trade tensions heightened, thereby impacting Fund performance. For the short end of the curve, yields fell as talk of future Federal Reserve interest rate cuts reemerged amid growing recession concerns.

The Fund's longer duration contributed to performance relative to the Index. Additionally, The Fund's allocations to asset-backed securities and investment-grade corporate bonds were beneficial to relative performance. There were no material detractors to the Fund's performance over the period.

# How did the Fund perform over the past 10 years?

The line graph below reflects a hypothetical \$10,000 investment and assumes the deduction of the maximum sales charge associated with that investment. The returns shown in the line graph and table assume the reinvestment of dividends and capital gains, but do not reflect the deduction of taxes that a shareholder would pay on distributions or the redemption of Fund shares. 
